Service agreement and notes

1. Sample

- •We accept formal reception with arrival of both sample and request form. In addition, please burden the shipping cost of the customer at the customer's share.
- •Please do not stick a small sample (such as foreign matter) with cellophane tape or the like. It leads to breakage of specimens, making the inspection extremely difficult.

2. Inspection service

(1)Inspection targeting DNA

(Inspection: target microbial DNA identification test, animal / plant DNA identification test, foreign body DNA identification test, insect DNA identification test)

•It may be impossible or undetectable due to following problem

(Mixed plural kinds, incompatibility of universal primer, influence of PCR inhibitor, degradation of DNA by pressurization, heating, fermentation)

2 Inspection fee at the time of inspecting / undetectable
